Dear Parents


The academy reopens again on Wednesday 4 September 2019 for students, please remember the late gate closes at 8.35am precisely, so please encourage your child to be on time.

of expectations from September 2019 which I have detailed below:

Mobile Phones:

A complete ban on the use of mobile phones for all students on school site. That is, once students are on site, mobile phones must be out of site and switched off for the duration of the school day. They must remain switched off until pupils leave the school site. Phones will be confiscated if they are seen on site, to ensure full compliance.

• Cycle/Scooter Safety:

From September 2019 we will be requiring every student who travels to and from the academy in this way to wear helmets. This is for the obvious safety reasons which are clear to us all. We will issue sanctions to students who arrive at the academy or attempt to leave without this vital piece of safety equipment. If any family feels that the price of a helmet is something they will need support with then please contact the academy and we will discuss what support, we can provide on an individual basis.

• Jewellery Expectations:

No jewellery to be worn during the academy day with the exception of a school watch and one stud earring in each ear, no visible necklaces and no bracelets or rings. **No** facial piercings.

Make-up & Hair:

No nail varnish/polish to be worn. Subtle make-up only to be worn. No extreme hair colouring.

• Uniform:

To be worn correctly at all times, shirts tucked-in and clip on ties worn appropriately, Suitable trousers and skirts to be worn (No jeans, leggings, tight fitting trousers or short skirts), appropriate footwear to be worn (at Farnborough this is solid black polishable footwear). Blazer sleeves not to be rolled up.

I know that the majority of these expectations are the ones we already have in place and you will see the benefit of the newer heightened expectations. A few may take a little getting used to as they are embedded, but students have proven this year that they are willing and able to rise to the challenge of higher expectations.

I would like to end by wishing you all a restful summer break and I hope you are able to spend time with your family and loved ones.
